#### **COMPANY POLICY**

It is an honor and a privilege to be a member of company. It is to be taken seriously and it is a commitment. It is a commitment that the parent must be willing to make as well. Parents will be expected to support their child in the responsibilities of Company. Parents are to be responsible for knowing rehearsal times, performances, costumes, etc. It is the parent's responsibility that student is to events on time and has what they need. If costumes need to be altered it is parent's responsibility to get it done on time. Parents are required to take the direction of directors Anne Reagan and Joanne Horn. Company parents will be asked to help in different capacities as needed e.g.: Parades, costuming, props etc. Parents are required to make sure company members are to be responsible for performances, choreographic material, proper uniforms, costumes, and make-up as well as coifed hair. In order to fulfill this commitment, student is to be committed to JRD Company and are not to participate in other studio teams or functions.

## ATTITUDE is very important. Company is working with one another, not against one another. It is being proud of being a part of Company, and everyone in it.

**PLACEMENT:** Placement is determined by several elements, e.g., Level, attitude, responsibility, maturity, age, and overall completion of the company. Moving from one company to the next is not to be considered as a promotion or demotion. It is upon the general need and objectives of each company that year. Candidates for the Sophisticated Company must have been in a ballet class at least one year prior to consideration. As a Sophisticated Company Member & Jr. Sophisticated Company Member it is required to take one 1 ½ hour ballet class. It is highly recommended that Difference Company Members also take one ballet class. All members are required to participate in ALL COMPANY PERFORMANCES September thru May, legitimate pardon is at the discretion of director Joanne Horn and Anne Reagan. Performances scheduled after June are highly recommended as the purpose of company is to perform and grow as a performer.

## PLACEMENT OF STUDENTS INTO ONE OF THE FIVE COMPANIES IS UPON SOLE DISCRETION OF JOANNE HORN or ANNE REAGAN.

**ESCROW ACCOUNT**: Halloween: \$95.00 due at Registration, Christmas escrow \$100.00 due October 11, 2024. Both costumes are used in many activities and recital. Recital Costumes, see school policy.

**REQUIREMENTS:** Any student who is considered for company must be enrolled and participating in two dance classes in two different subject areas at JRDS. STUDENT'S BILL MUST REMAIN CURRENT TO KEEP STATUS IN COMPANY. Members considered for Jr. Sophisticated and Sophisticated Companies must be enrolled in ballet class. All Members MUST Begin in September or wait until the following year (special invitation during the dance year is the discretion of Joanne Horn or Anne Reagan).

**UNIFORMS:** Proper uniform is a required part of company for discipline and the importance of the performers costume requirements. All company members are required to wear the company uniform to all company classes, make up classes, and rehearsals.

**COMPANY AND CLASS MATERIAL:** Company members are to have their class and company work perfected through practice at home and attentive work in class. They are to bring CD's to have their music recorded if a pre-made CD is not available.

**ATTENDANCE:** Company members are to attend their class requirements. They are to be punctual to class times, rehearsals and performances. Tardiness and absences will not be tolerated. Company members are required to pay for all company rehearsals and there are no excused absences, even if you are not performing (Disney or selected member rehearsals are an exception). If a member must be late or absent due to an emergency or unexpected circumstance, they are to call the studio.

#### ALL COMPANY MEMBERS MUST ATTEND ALL RECITAL REHEARSALS!! Company Rehearsals are generally posted well in advance. If you have a trip or event that is well in advance, notification must be made to Miss Anne Reagan at least 2 months in advance. NO Excused absences in May! Failure will result in losing position in production or possible dismissal.

#### REMEMBER THAT PERFORMANCE REQUIRES THINKING AND THAT REQUIRES CLASS AND PRACTICE!!

**PURPOSE:** The purpose of the companies at the Joanne Reagan Dance Studios is to give students the opportunity to perform more than the spring musical. Through this opportunity students experience the elements and requirements of live performance in many settings other than a state-of-the-art theatre. This teaches students to be able to adjust and adapt to any situation. It teaches them to compensate and deal with different circumstances. It also teaches students the importance of working together as a team in a healthy supportive environment. It exposes students to various elements of versatility that are needed for theater dance performing and life!!
